

## **Corrigendum to Section 42A Report - Proposed Waikato Regional Plan Change 1 – Waikato and Waipā River Catchments**

This corrigendum has been prepared in response to the letter from Wairakei Pastoral Limited (WPL) to the Hearings Panel dated 21 January 2019, regarding some of the recommended changes to Plan Change 1 in the Section 42A Report published on 14 January 2019. WPL is concerned that in relation to some of the recommended changes, only the submitter name and not the relevant submission number(s) has been identified in the Section 42A report.

WPL has requested that *“the Commissioner direct Waikato Regional Council (WRC) to rectify these omissions by providing a corrigendum listing in respect of each of the relevant footnotes both the submitter name and the relevant submission point relied on for the jurisdictional scope for recommended changes in the report”*.

In a Minute from the Hearing Panel dated 21 January 2019, the Hearing Panel directed that *“A corrigendum listing in respect of each of the relevant footnotes both the submitter name and the relevant submission point relied on for the jurisdictional scope for recommended changes in the report.”*
