ENVIRONMENTAL INITIATIVES FUND

PROJECTS FUNDED IN THE 2025 FUNDING ROUND

ABOUT THIS FUNDING ROUND

A total of 32 applications were received in the 2025/26 Environmental Initiatives Fund (EIF) round, totalling \$1,029,665.24 in requested funds. 1 application was ineligible, and 16 applications were declined. Grants totalling \$478,557.60 were made to 15 projects.

DRIVING CREEK RAILWAY ARTS AND CONSERVATION TRUST

Project: Whangarahi (Driving Creek) Catchment Conservation

District: Thames-Coromandel

EIF Contribution: \$17,680 (\$9,360.00 in Year 1; \$8,320.00 in Year 2)

Duration of Funding: 2 years

The Driving Creek Railway Arts and Conservation Trust was established to protect and enhance the biodiversity of the 23ha QEII covenanted property and the surrounding 300ha buffer zone near Coromandel town. This funding will be used to support targeted pest plant control throughout regenerating indigenous podocarp-broadleaf forest.

FRIENDS OF MANGAONUA ESPLANADE SOCIETY INCORPORATED

Project: Mangaonua Gully Restoration

District: Hamilton City

EIF Contribution: \$37,947.68 (\$22,440.36 in Year 1; \$15,507.32 in Year 2)

Duration of Funding: 2 years

Friends of Mangaonua Gully is a charitable trust with an aim to restore the original biodiversity of Mangaonua Gully and foster community engagement and guardianship. The approved funds will be used to support the pest plant control around young native plantings and prepare sites for new plantings to be established by community volunteers.

HAAKARIMATA RESTORATION TRUST

EIF Contribution: \$36,244.01 (\$23,271.01 in Year 1; \$12,973.00 in Year 2)

Duration of Funding: 2 years

The Haakarimata Restoration Trust (HRT) was formally established in 2025 to protect, restore, and enhance the ecological, cultural, and social values of the Haakarimata Ranges, building on previous volunteer and community-led restoration efforts. The approved funds will be used to enable community engagement and capability building, workshop delivery, biodiversity monitoring and administration support.

KUKUTARUHE EDUCATION TRUST BOARD

Project: The Fairfield Project - Kukutaaruhe Gully Restoration

District: Hamilton City EIF Contribution: \$23,944.00

Duration of Funding: 1 year

The Fairfield Project, governed by the Kukutaaruhe Education Trust (KET), was established in 2017 as an intergenerational, community-led restoration and educational project with the aim to connect the community with urban green spaces. The approved funds will be utilised to support project management for ecological restoration.

Ngāti Maru Ki Hauraki Incorporated on behalf of Ko Moehau ki Tai, is a Hauraki iwi led initiative focused on restoring indigenous biodiversity and protecting the cultural and ecological values of their ancestral land. This funding will be used to develop and maintain a possum control programme for Pōhutukawa protection in the northern Coromandel.

NGĀTI TAMATERĀ TREATY CLAIMS TRUST

Project: Ō-kahu-tai Environmental Weed Control

District: Thames-Coromandel

EIF Contribution: \$34,320.00 (\$17,160 in Year 1; \$17,160 in Year 2)

Duration of Funding: 2 years

Ngāti Tamaterā Treaty Claims Trust is an Iwi organisation on the Coromandel Peninsula. One of the trust's focus areas is the restoration of whenua that holds significance to their Iwi. Funding will be utilised to support the management of pest plants in areas of high value biodiversity.

NGĀTI TE MAUNGA WHENUAKURA INCORPORATED

Project: Whenuakura Ecological Management Plan 2025-28

District: Taupō

EIF Contribution: \$39,887.82

Duration of Funding: 1 year

Ngāti Te Maunga Whenuakura Incorporated is a hapū organisation working to protect and restore rare ecosystems in the southern Pureora area. The approved funds will go towards purchasing trapping materials to establish a predator control network throughout the Whenuakura frost flat.

PROJECT KIWI TRUST

Duration of Funding: 2 years

Project Kiwi Trust is a Kiwi conservation group established in 1996 to protect Coromandel brown kiwi on the Kūaotunu Peninsula with a key focus on mustelid control. Funding will be utilised to purchase predator control materials and support track maintenance throughout the project area.

TE RANGA WAIRUA TRUST

Duration of Funding: 1 year

Te Ranga Wairua Trust is a Ngāti Porou ki Hauraki initiative that has recently formalised into a trust after years of iwi/volunteers working on the Te Ranga Wairua environmental restoration project. This funding will go towards track cutting and the purchase and installation of predator control materials for the protection of Australasian bittern.

TE REKEREKE TAIAO TRUST

Te Rekereke Taiao Trust is a community group operating in and around the Raglan area to create and strengthen forest and wildlife corridors and empower communities to identify and control pest plants and be part of the recovery of threatened native plant species. This funding will go towards the development of a series of educational videos for pest plant identification and control and expanding the library of pest plant control tools.

The funding for this project will be used to carry out pest plant control activities and for materials to support and extend their current predator control programme.
